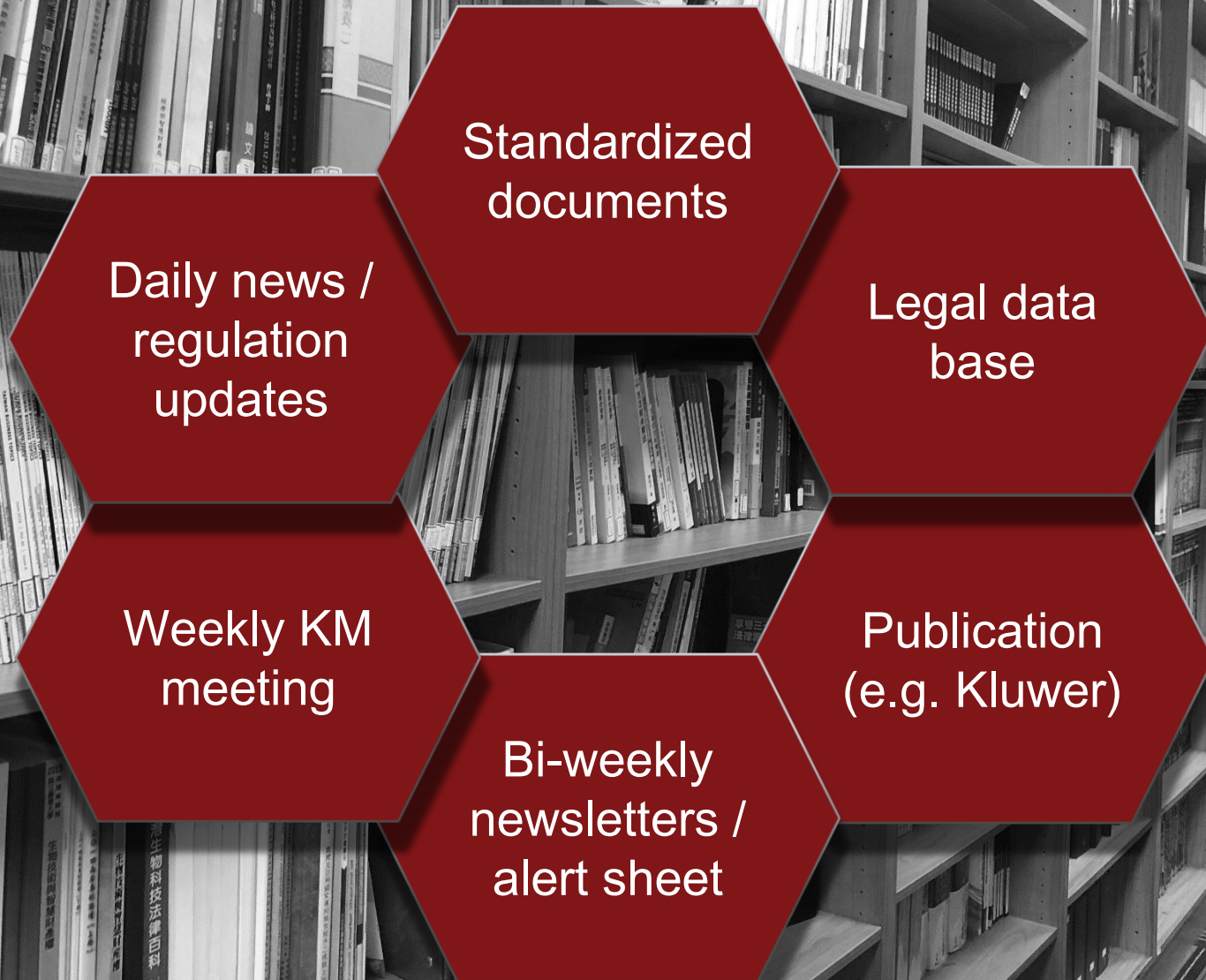

1. *Amendments to Ruling Regarding Issuance of Employee Stock Option and Transfer of Treasury Stock to Employees*

On 15 June 2018, the Financial Supervisory Commission (FSC) issued a ruling to amend a previous ruling in connection with the issuance of employee stock option and transfer of treasury stock to employees of public reporting companies. We summarize the key points below:

- (1) To allow a public reporting company to issue employee stock option and transfer treasury stock to its non-full time employees and such employees of its onshore and offshore subsidiaries.
- (2) To require a public company to specify in its stock option and treasury stock transfer rules the criteria for the determination of the status of employees.
