This 4-half-day virtual event, which featured keynote speeches, presentations and panel discussions, was conducted primarily in English to a global audience of over 1000 participants





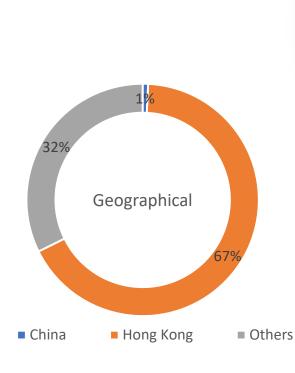

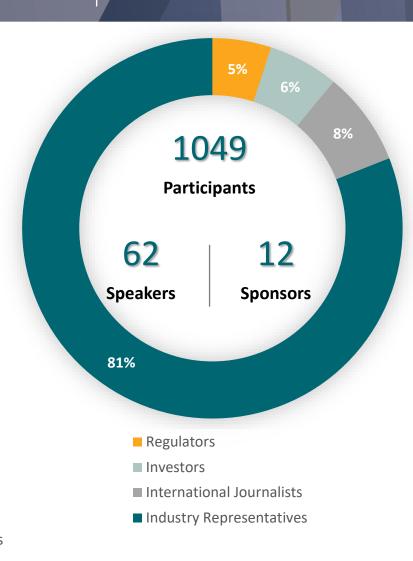

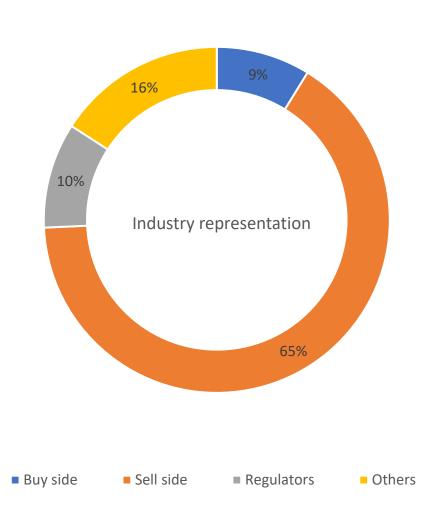
